ORDINANCE No. 185676

Amend an Intergovernmental Agreement with Portland Community College for ongoing Emergency Medical Services training (Ordinance; amend Contract No. 30001806)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On December 15, 2010, Council passed Ordinance 184313, authorizing Contract No. 30001806 with Portland Community College for on-going training to meet the State of Oregon and Multnomah County Continuing Medical Education courses required for firefighters to maintain their EMT certifications.
- 2. Section 4.c.of that IGA states that employees may make up missed classes by attending regularly scheduled classes on campus at the contract rate, but doesn't define that rate.
- 3. Amendment No. 1 of Contract 30001806 changes the name of the school and school phone numbers, defines the individual class rate, and raises the cost of individual cards for students.
- 4. There is a potential for PF&R to incur an additional \$5,000 every four (4) years for individual classes.
- 5. PF&R has the funds for this training in its budget.

NOW, THEREFORE, the Council directs:

a. The Commissioner of Public Safety and Auditor are authorized to execute an amendment to Contract 30001806 with Portland Community College CLIMB Center for Advancement-Health Professionals as outlined in a form substantially in accordance with the amendment attached hereto as Exhibit A, at a cost not to exceed an additional \$5,000 every four (4) years.
