

**ORDINANCE No. 185681**

Authorize a contract with Brown and Caldwell, Inc. for professional services for the Alder Wastewater Pump Station Upgrade Project No. E10359 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has need of a consulting engineering firm to provide professional engineering services for the Alder wastewater pump station upgrade, Project No. E10359.
2. Consultant selection has been conducted in accordance with Chapter 5.68 of the Code of the City of Portland (RFP BES127). The consultant selection committee recommends that Brown and Caldwell, Inc. (B&C) be retained to provide the required professional engineering services.
3. The estimated cost is \$357,693. M/W/ESB participation is \$147,645 or 41.3% of the total contract amount. Funds are available in the Sewer System Operating Fund, FY 2013 Budget, Bureau of Environmental Services, WBS Element E10359.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with Brown and Caldwell, Inc. for the purpose described in Section 1, in the amount of \$357,693.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
