

ORDINANCE No. 185685

*Authorize an Intergovernmental Agreement with Portland State University, College of Urban and Public Affairs, Institute of Metropolitan Studies to provide funding for tracking and updating of data through the Greater Portland Pulse Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland State University's College of Urban and Public Affairs Institute of Portland Metropolitan Studies administers a project called Greater Portland Pulse (GPP) to identify outcomes relevant to the well-being of the region and establish measures that track progress toward those outcomes.
2. The PSU GPP project started as a partnership with Metro on the Greater-Portland-Vancouver Indicators project to engage members of different communities to choose, measure and apply a set of indicators to measure social, economic and environmental well-being and help those communities collaborate across boundaries on regional solutions.
3. By Resolution 36918 on April 25, 2012, Portland City Council adopted the Portland Plan with a set of strategies to promote thriving educated youth, economic prosperity and affordability and a healthy connected city and established a set of indicators to measure progress toward those goals.
4. The City and Portland State University agree it would benefit the community for the City to transfer Portland Plan data to the GPP project for the Institute of Metropolitan Studies to maintain and refine the Portland Plan indicators and provide an update on improvements to the data and the City's progress in meeting objectives.
5. The established cost for administration in Fiscal Year 2012-2013 is \$20,000. Funds are available in adopted FY 12-13 budget for the Bureau of Planning and Sustainability, Center Code PNCP 000001.

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Planning and Sustainability is hereby authorized to sign an agreement with the State Board of Higher Education by and through Portland State University, College of Urban and Public Affairs, Institute of Metropolitan Studies, for the purpose described in Section 1, in a form substantially in accordance with the agreement attached as Exhibit A.

- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Bureau of Planning and Sustainability, Cost Object PNCP000001 when demand is presented and approved by the proper authority.
- c. The Director of the Bureau of Planning and Sustainability is hereby authorized to sign amendments for continuing data management, reporting and funding in future fiscal years if appropriations are approved by City Council.

Section 2. The Council declares that an emergency exists in order to forward funds for services to continue work that benefits the City. Therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


