

ORDINANCE No. 185690

Renew contract with Centennial School district for Afterschool At-Risk Meal and Snack Program sponsorship (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Parks & Recreation has since 2010 been a sponsor of an Afterschool At-Risk Meal and Snack Program, administered by the Oregon Department of Education's Child Nutrition Program. Through this program, children enrolled in afterschool education or enrichment programs receive free nutritious meals and snacks. Program sponsors are eligible for federal reimbursement of costs.
2. St. Johns Community Center and Charles Jordan Community Center are participating for the 2012-2013 school year.
3. The Oregon Department of Education requires sponsors to annually renew their sponsorship agreements.
4. Portland Parks & Recreation provides meals for this program via a vended meal agreement with Centennial School District. This agreement is also renewed annually.
5. The project budget for the 2012-2013 school year is \$42,000, with \$40,000 projected in federal reimbursement.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Education for the Afterschool At-Risk Meal and Snack Program in the amount of \$40,000.
- b. The Portland Parks & Recreation Director is hereby authorized to enter into a vended meal agreement with Centennial School District in a form substantially in accordance with the agreement attached as Exhibit A.
- c. The FY 2012/2013 budget is hereby amended as follows:

- d. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.


