The total estimated cost for the both the public and private portions of the pilot projects is \$5.5 million. \$3.5 million for the construction on public property is included in the BES Capital Improvement Program budget. The private property work estimated to be \$2 million and will be included in future requested operating budgets. The source of funding is BES revenue from rates and bond proceeds. The level of confidence in this estimate is Low. Higher confidence estimates will follow as a result of the pilot project work.
