

ORDINANCE No. 185713

Authorize a contract with BergerABAM, Inc. for professional engineering services for the Tryon Creek Sewer Upgrade Project No. E10251 and provide for payment (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Tryon Creek sewer pipeline (sewer) is located above the head-works of the Tryon Creek Waste Water Treatment Plant, along the shoreline of Tryon Creek, and within Tyron Creek State Park.
2. Sewage has begun to seep from the sewer at pipeline joints and manhole connections.
3. Structural integrity of the reinforced concrete footings, piers, braces, and straps supporting the sewer may be at risk of failure.
4. Professional, Technical, and Expert consulting services are necessary to perform an inspection, evaluation and design of sewer upgrades necessary to eliminate sewage leaks and to restore structural integrity of the sewer supports and pipeline.
5. The consultant selection has been conducted in accordance with Chapter 5.68 of the Code of the City of Portland (RFP No. BES128.)
6. The consultant selection committee recommends that BergerABAM be retained to perform the design services through construction.
7. An amendment to the Agreement for services upon completion of the Design Phase of the Tryon Creek Sewer Upgrade Project will include cost of Bidding Assistance and Construction Inspection support during the Advertising and Construction Phase of the Tryon Creek Sewer Upgrade Project.
8. The percentage of M/W/ESB participation on this contract is 24%.
9. The established cost is \$471,410.00. Funds are available in the Sewer System Operating Fund, FY 2012-13 Budget, Bureau of Environmental Services, Project No. E10251, Account No. 521000.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with BergerABAM, in a form substantially in accordance with the contract attached as Exhibit A, for the purpose described in Section 1, in the amount of \$471,410.00.
