
#### 1) Legislation Title:

#### 2) Purpose of the Proposed Legislation:

Authorize the execution of a Disposition Agreement (DA) for the transfer of City-owned property, the remaining eastern portion of Block U comprising 17,500 square feet, to the County of Multnomah Oregon for the development of a new Multnomah County Health Department clinic and headquarters.

The legislation will not directly increase or decrease revenue coming to the City.

The land has an estimated value of almost \$2M and a City "book value" of \$363,638. PHB will convey the land at no cost to the County for a community facility. Although this might be seen as foregoing future revenue, in practice, PHB generally provides financial resources, including real property at no cost, to assist in making targeted projects feasible or affordable.

The land value estimate of almost \$2M is based on old appraisals and County data on other land transactions. The value of the parcel will be determined by appraisal before conveyance.

## a) What impacts are anticipated in the community from this proposed Council item?

County staff has described the overall reaction of neighborhood stakeholders as "cautiously supportive." Stakeholders acknowledge that the development could benefit the neighborhood but also voice concern that the appropriate balance be struck between essential social services, businesses and residential needs. Residents and businesses are enthusiastic about having more people with disposable income to shop and eat in the neighborhood but are also concerned about possible impacts of the many health clinic clients, specifically parking. There is concern about any additional concentration of social services in the neighborhood. There is overall consensus that this project would serve as a compatible neighbor to the Bud Clark Commons and that development of a vacant lot is highly desirable.

## b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

Staff from the Multnomah County Health Department and from Chair Cogen's Office were responsible for public involvement and community outreach. #### c) How did public involvement shape the outcome of this Council item?

By pursuing the development of this building, Multnomah County is responding to a well-known need of the Health Department – which serves all 735,000 Multnomah County residents. Citizen involvement is pivotal to the Health Department's decision-making. Citizens serving on the County's Community Health Council work closely with County leaders to provide community guidance on all programs and policies affecting the health of county residents. In this particular effort, Multnomah County leaders started engaging with community stakeholders in surrounding neighborhoods in 2011, and are committed to continuing open lines of communication so that this project can meet the needs of all affected.

In addition, the PDC Board recently approved a Third Amendment to the River District URA Plan which was required for this project. Public involvement helped shape the PDC Board's decision to take that action.

Home Forward worked on community outreach with the County. Staff of the Multnomah County Health Department and Multnomah County are responsible for public involvement.
