### Requested Council Hearing Date:

#### I. RECOMMENDATION

Authorize Grant Agreement with Johnson Creek Watershed Council

#### II. **BACKGROUND**

The Johnson Creek Watershed spans across the political boundaries of four cities and two counties. 39.5% of the watershed falls within the City of Portland. While the City's ability to implement projects and policy is strongest within its own jurisdiction, our efforts are more effective when approached on a watershed basis. The Johnson Creek Watershed Council provides a crucial link to the citizens, business and jurisdictions both within Portland's boundaries and throughout the watershed.

In 1990, a group of concerned residents and business owners joined with representatives of government agencies and formed the Johnson Creek Corridor Committee (JCCC) to begin seeking solutions to Johnson Creek's problems. In May of 1995, the JCCC published the Johnson Creek Resource Management Plan as a comprehensive plan for managing resources in the Johnson Creek watershed. After completion of the management plan, the JCCC evolved into the Johnson Creek Watershed Council. For the past nine years, BES has funded contracts with the Johnson Creek Watershed Council to assist them in program development, restoration projects and outreach. The mission of the watershed council is "to promote restoration and stewardship of a healthy Johnson Creek Watershed through sound science and community engagement.".

Johnson Creek has been identified as the most critical habitat within the City's streams system for steelhead spawning and rearing. With the recent listing of fish species as endangered under EPA's Endangered Species Act, the mission of the watershed council becomes all the more important.

The Watershed Council plays a key role in coordinating watershed events such as the Johnson Creek Days and the Johnson Creek Watershed Wide Event. These large scale efforts, along with 30 smaller volunteer events, have encouraged more than 1100 volunteers to actively participate in promoting the health of Johnson Creek. The Watershed council recently completed a habitat restoration project at the confluence with the Willamette River, and is currently working with TriMet to include habitat enhancement as part of the Milwaukee light rail line.

Continued funding for the Johnson Creek Watershed Council will enable the council to implement their work plan within the City of Portland and will leverage additional funds from the other jurisdictions, Metro and the Governors Watershed Enhancement Board. By doing so, our support will lead to a healthier stream and watershed and increased public awareness and participation.

#### III. FINANCIAL IMPACT

\$5,000 per year for three (3) years – Total amount not to exceed \$15,000

#### IV. LEGAL ISSUES

Legal issues and requirement for the City of Portland include:

- National Pollution Discharge Elimination System (NPDES) Permit
- DEQ 303(d) Listing
- Endangered Species Listing

The Johnson Creek Watershed Council's workplan throughout the watershed will assist the City of Portland in meeting the legal requirement as listed above.

#### V. CONTROVERSIAL ISSUES

Grant support for services with the Johnson Creek Watershed Council supports a mechanism for watershed-wide coordination that is not available through any other entity. Furthermore, citizens who are interested in protection and enchantment of their property, but are not inclined to partner with a government agency, have access to information and assistance.

Support for the watershed council has led to action and implementation in restoration, land use over sight, support for policies that promote natural resource protection, watershed education, and public involvement. Continued support will assist the City's efforts as we reach out to the Johnson Creek community on these issues and those related to the ESA listings, and development.

# VI. LINK TO CURRENT CITY POLICIES

Funding the Johnson Creek Watershed Council work plan is consistent with the goals of many current city policies and programs. For example:

River Renaissance Endangered Species Act Response Clean Rivers Program Sustainable City Principles The watershed council promotes a high level of public involvement, which is consistent with the city's efforts to build community participation, education and support.

#### VII. CITIZEN PARTICIPATION

The emphasis of the watershed council is community involvement. Residents, businesses, schools, agencies, and jurisdictions are the focus of the council's outreach and involvement efforts. The council counts almost 300 due's paying members, had 1,100 volunteers during 2011, and hosts approximately 40 different public events throughout the year.

### VIII. OTHER GOVERNMENT PARTICIPATION

- The City of Gresham, Multnomah County and City of Milwaukie all fund direct contracts with the watershed council. Other jurisdictions within the watershed (Happy Valley, Clackamas County) contribute to the council through in-kind contributions of staff or materials. An inter-jurisdictional committee comprised of staff from each jurisdiction and the watershed council is working cooperatively on technical issues such as water quality, fish habitat and flooding. Elected officials from each of the jurisdictions in Johnson Creek are invited to participate in the Johnson Creek Policymaker Committee.
