## 185740 ORDINANCE No.

Terminate Cooperative Improvement Agreement with the Oregon Department of Transportation and Metro for the Peninsula Crossing Trail - North Portland Road Section (Ordinance; amend Contract No. 51267)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. In 1995, voters approved Metro's Bond Measure 26-26 for Open Space, Trails and Streams, and Metro subsequently approved a work plan and budget that included funds to design and construct the Peninsula Crossing Trail.
- 2. Segments 1 and 2 of the Trail, between Willamette Boulevard and North Portland Road were built in 1999.
- 3. The City of Portland entered into Cooperative Improvement Agreement 51267 (authorized by Ordinance 174084) with Metro and ODOT in January 2000, which specifies responsibilities for design, construction, and maintenance of Segment 3, on ODOT's North Portland Road right-of-way.
- 4. Segment 3 was completed in 2000.
- 5. In November 2007, Council passed Ordinance 181407, authorizing Jurisdictional Transfer 770, which transferred responsibility of Swift Highway (Marine Drive and North Portland Road) to PBOT.
- 6. Jurisdictional Transfer 770 states that the City "agrees to...maintain the property as portions of its city street system...including...bike paths".
- 7. The City has sole responsibility to maintain Segment 3 of the Peninsula Crossing Trail; contract 51267 is no longer needed.

NOW, THEREFORE, the Council directs:

The Commissioner-in-Charge and Auditor are hereby authorized to amend contract a. 51267 in a form substantially in accordance with the amendment attached to the original of this ordinance and, by reference, made a part hereof.
