

**ORDINANCE No. 185782**

\* Authorize a Memorandum of Agreement with the Corporation for National and Community Service for AmeriCorps Volunteers to continue volunteer service to strengthen and supplement efforts to eliminate poverty and poverty-related human, social and environmental problems (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Mayor's Office applied to Corporation for National and Community Service for a grant for five Americorps VISTA volunteers on 12/15/2010.
2. The City of Portland was awarded a grant for the Americorps VISTA to the Mayor's Office and Portland Parks and Recreation and entered into an MOA that was effective 5/31/11 – 6/2/12, with a cost share obligation of \$10,692 (Ordinance #184349).
3. The MOA between the City of Portland and the Corporation for National and Community Service will extend the relationship to be valid 6/3/12 – 6/15/13.
4. The City will have a cost share obligation of \$10,704 for this extended timeframe.
5. The Corporation for National and Community Service and the City of Portland has signed a memorandum of agreement, attached as Exhibit A.
6. The amount of this cost share is not to exceed \$10,704.00.


NOW THEREFORE, The Council directs:

- a. The City of Portland designates and authorizes the funding contained in this ordinance. The Office of the Mayor is authorized to execute, on behalf of the City, a Memorandum of Agreement with the Corporation for National and Community Service in a form substantially in conformance with Exhibit A attached to this ordinance.
- b. The Mayor and Auditor are authorized to draw and deliver checks not to exceed \$10,704 to the Corporation for National and Community Service, chargeable to the FY 2012-13 Mayor's Office Education Program budget.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to make payment for activities authorized by the MOA. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.

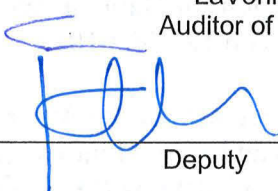
