# **REPORT TO COUNCIL**

# Appoint Members to the Arts Education & Access Fund Citizen Oversight Committee (Report)

In the November 6, 2012, General Election, City of Portland voters approved Measure 26-146, creating the Arts Education & Access Income Tax and Arts Education & Access Fund to restore school arts and music education and fund the arts.

One of numerous accountability measures approved by voters was the adoption of City Code provision 5.73.050 that created the Arts Education & Access Fund Citizen Oversight Committee.

The citizen oversight committee shall be representative of the City's diverse communities, consist of a minimum of ten and a maximum of twenty members, including, if possible, a member of the Tax Supervising and Conservation Committee.

The committee is charged with reviewing the expenditures, progress and outcomes of the Arts Education & Access Fund and reporting their findings in a public record to the City Council on an annual basis.

The committee shall meet at least twice annually.

The committee shall have at least one, but no more than two, Chairs appointed by the Mayor.

Citizens may be reappointed to serve an additional two-year term at the conclusion of their initial term, but may serve no more than two terms.
