County Election officials and the Tax Supervising and Conservation Commission estimate the Special Election cost to be approximately \$36,000.

The City will pay approximately \$44,000 to place the Children's Levy on the May 2013 ballot. Adding this second measure would cost an additional approximately \$36,000. If additional measures are added to the May 2013 ballot by other jurisdictions, the City's cost for both measures would be lowered.

In September, Portland City Council heard extensive testimony from constituents and took in a significant volume of public comment, before voting to move forward with a plan to fluoridate the public drinking water supply. At the time, many opponents of the fluoridation plan requested that council put the issue to an immediate public vote.

Following that council decision, the Clean Water Portland Referendum Committee collected signatures from an estimated 33,015 valid City of Portland registered voters, qualifying for the ballot.

This measure before council would set the date of a public vote to May 21, 2013. During that election, Portland voters will decide whether to uphold the Portland City Council's vote to fluoridate the City of Portland's public drinking water supply. It is expected that there will be extensive community debate regarding the issue.
