Total revenue to be received by City for increased staff services rendered over next several fiscal years will increase from around \$12.8M to \$14.4M, with PBOT's share increasing from \$7.1M to \$7.5M.

5) Expense: What are the costs to the City related to this legislation? What is the source of funding for the expense? Betterments requested by the City to be constructed with the light rail project will be paid for by each bureau requesting the addition: BES - \$4,287,446; PWB - \$510,919; PBOT - \$296,362. Funding sources and year of payment for each betterment varies by bureau. For PBOT, betterments are paid by: arterial performance project (\$1,600); SW Moody project (\$10,000); Innovation Quadrant TSDC (\$284,762) per ordinance 185580.
