TO THE COUNCIL:

The Chief Procurement Officer is submitting this report and recommending that Portland Fire & Rescue and Procurement Services be authorized to proceed with awarding a contract to Oregon Iron Works, Inc. in the amount of \$1,690,100.00.

By way of background, Ordinance number 185401 passed by Council on June 6, 2012, authorizing Procurement Services to issue a Request for Proposal (RFP) for the manufacture, delivery and attachment of one (1) boathouse to existing pilings at Fire Station 21. At that time the project had a cost estimate of \$801,517.00 and was rated with a Low confidence level.

The Chief Procurement Officer advertised RFP No. 114647, issued on October 8, 2012, for the Portland Fire & Rescue Station 21 Boathouse. A pre-proposal meeting was held in which six interested firms were in attendance. Proposals were due on November 6, 2012 and one (1) proposal was received. A five (5) person selection committee with representatives from Portland Fire & Rescue and the Minority Evaluator Program reviewed, evaluated, and scored the response in accordance with Portland City Code 5.33. Oregon Iron Works, Inc. was determined to be responsive to the City's RFP #114647. The City issued a Notice of Intent to Negotiate and Award a contract to Oregon Iron Works, Inc., on November 8, 2012.

Funding for this project is through a Federal Emergency Management Agency Grant and from the General Obligation Bond. At this time, having worked to negotiate this contract, the Portland Fire & Rescue has a High confidence level in the cost estimate for this project.

Oregon Iron Works, Inc., has a current City of Portland business license, is in compliance with the Equal Benefits Program, and their EEO Certification is current through February 1, 2014. The company is located in Clackamas, OR and is not a State of Oregon Certified M/W/ESB contractor.
