The *Plans Examiner* is widely distributed electronically to BDS customers and stakeholders, as well as neighborhood associations and community groups.

Subsequent to these outreach efforts, applications were received by ONI and forwarded to BDS.

d) Who designed and implemented the public involvement related to this Council item?



Portland City Code Title 3.30.030 specifies that members of the Development Review Advisory Committee (DRAC) may serve no more than two, complete 3-year terms. There are currently several vacancies on the DRAC. After a thorough review process, I am recommending the following candidates for appointment to the DRAC:

Phil Damiano is a Senior Program Manager at PECCI, a firm that designs and manages energy efficiency programs for a variety of clients. He previously spent 12 years at NW Natural focused on activities associated with single and multi-family residential new construction. Phil also serves as a board member of the Home Builders Association and has been a green building advocate at the local, state, and national levels. Phil would be completing a partial term for a prior DRAC member who resigned from the DRAC before the end of his term.

Christopher Kopca is the Asset Manager for Downtown Development Group LLC, and previously was the Development Manager for the Portland Development Commission. He is a member of the Building Owner Manager Association (BOMA) board, and he previously served as a member and Chair of the Portland Design Commission.

The background and experience of these candidates will make them welcome additions to the DRAC. Their appointments will help ensure the continuation of the good work of the DRAC on behalf of BDS and other City bureaus, the development industry, and the community. If these proposed appointments are approved, two vacancies will remain on the DRAC. We are continuing our outreach efforts to fill these vacant positions.

Development Review Advisory Committee:

The Development Review Advisory Committee (DRAC) is a citizen advisory body, representing those with interests in the outcome of policies, budgets, regulations, and procedures that affect development review processes. The purpose of the Committee is to foster a timely, predictable and accountable development review process that implements the City's goals for land use, transportation, housing, economic development, neighborhood livability and the environment. The Committee advocates for and supports consistent and fair application and implementation of regulations.

The Development Review Advisory Committee consists of seventeen members. These members are appointed by the Commissioner in Charge and confirmed by the City Council. The members are elected to provide representation of those persons concerned about planning, design and development. The areas of interest of members shall include, but not be limited to, development, planning, construction contracting, design professions, neighborhood association membership, business association membership, historic preservation, environmental organizations, and institutional properties. Members of the Development Review Advisory Committee shall serve no more than two, complete three-year terms.
