WHEREAS, Portland Parks & Recreation and Bureau of Environmental Services commissioned a concept plan to address the many internal and external factors acting on Willamette Park (26.5 acre) at SW Macadam Ave & Nebraska St.

WHEREAS, the concept plan for the park was prepared with an advisory committee comprising representatives from the South Portland Neighborhood Association, Parks advocates, and members at large.


WHEREAS, there were five PAC meetings and one open house, a public comment period, and additional targeted outreach to gather public input during the project.

NOW, THEREFORE, BE IT RESOLVED, that the City Council affirms its acceptance of the 2012 Redevelopment and Phasing Plan for Willamette Park as a guide for future development of the park.

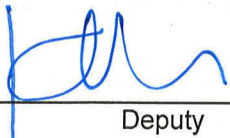
