a) What impacts are anticipated in the community from this proposed Council item?

Willamette Park is a well utilized park, both regionally and locally. It provides the only boat launch on the west side, the only off-leash dog area within several miles, and it includes a portion of the Willamette River Greenway that serves recreational and commuter cyclists and walkers and runners. This high volume and variety of uses has led to multiple efforts over the years to envision a way to more effectively use the space and to also reduce conflicts among users.

This proposal successfully improves the functionality of the park while maintaining an enhancing the experience of the park users.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

Advisory Committee Recruitment – this opportunity was made available through the SWNI News, South Waterfront E-current, adjacent neighborhood association, community-based organizations representing dog owners, boaters, the local business community, sports teams and trail users. All persons who had reserved the space for an event or activity were notified of the opportunity. This notification went out several times.

The opportunity to comment on the draft redevelopment plan was sent to the above lists. Additionally, signs for the event were placed in the park and adjacent neighbors received notification via fliers distributed door-to-door.

c) How did public involvement shape the outcome of this Council item? The Advisory Committee used a consensus based process to make a recommendation on the design. Additionally, committee feedback was solicited and incorporated into the final report. The response from the Open House indicates strong community support for the final redevelopment plan.
