On behalf of the United Nations Environment Programme, I would like to thank Mayor Hales and Portland's Council Members for accepting our invitation to be the host City for this year's North American World Environment Day celebrations.

Mayor Hales, today you join the mayors of other great North American cities who have hosted World Environment Day: Chicago, Omaha, Pittsburgh, Toronto and Washington, D.C.

And, let's not forget San Francisco who hosted the global WED celebrations in 2005.

World Environment Day was established by the United Nations General Assembly in 1972.

It is commemorated every year on the 5th of June in more than 120 countries around the world.

This Day, administered by the UNEP, is one of the principal vehicles through which the UN stimulates worldwide awareness and focuses political attention and action on the environment.

With thousands of events organized around the globe, World Environment Day is considered one of the largest environmental events of its kind.

Some may ask: why have we selected Portland, Oregon?

The reasons are many and the answer is simple.

Portland is a leader in green infrastructure and in the protection and restoration of its natural environment.

Portland has been selected because we at UNEP would like to put the spotlight on the city's environmental achievements.

Those achievements are reflected in the fact that this City is repeatedly ranked among the top 10 green cities in the United States.

In our research, Portland is often rated the number one green city in North America – an impressive accomplishment by any standard.

Your stellar reputation is due to innovative initiatives and recognition for sound leadership, good planning and hard work.

Rest assured that your efforts have not gone unnoticed by the international community.

Portland set the bar for sustainability more than 30 years ago when freeway-building was the order of the day. You broke ranks and tore down a six-lane expressway to make room for a waterfront park.

Since then, you have set an urban growth boundary that today allows residents to enjoy more green spaces.

As the first U.S. city to have a plan to reduce the greenhouse gas carbon dioxide, you now boast that much of your energy comes from renewable sources such as hydroelectric, conservation and solar power.

Your city also boasts the nation's highest percentage of bicycle commuters who are supported by a 315-mile network of bikeways.

Also impressive is your solid-waste program that recycles more than half of the city's trash, including glass, metal and plastics, and composts yard waste and food scraps from businesses.

With ingenuity as your guide, you have timed traffic signals to reduce annual gas consumption by 1.75 million gallons – the equivalent of more than 15,000 tons of CO2 emissions.

Always thinking ahead, you have banned single use plastic bags at large retailers and steps have already been taken to phase out single use bags at all stores and food providers by late 2013.

These are just a few reasons why the United Nations Environment Programme has selected Portland, Oregon as the North American host city of World Environment Day.

The World Environment Day theme this year is food waste.

And the slogan is *Reduce your Foodprint!*

This issue is one of great relevance to North America, and we look forward to working with all of you and the entire Portland community to raise awareness about the need to change the culture of food waste.

UNEP's vision for World Environment Day in 2013 is to help us bring the food waste message home in a way that will make a real difference.

The statistics are staggering.

In developed regions like Europe and North America, 300 million tons of food is wasted annually because producers, retailers and consumers discard food that is still fit for consumption.

Worldwide, 33% of all food produced – worth around US\$1 trillion – gets lost or wasted in food production and consumption systems.

In a world of seven billion people, set to grow to nine billion by 2050, wasting food makes no sense – economically, environmentally and ethically.

The global food system has profound implications for the environment, and producing more food than is consumed only exacerbates the pressures.

We look forward to working with businesses, non-governmental organizations and individuals in organizing informative, inspiring and vibrant activities, not only on World Environment Day, but during the six weeks between Earth Day on April 22nd and World Environment Day on the 5th of June.

This Bridging the Gap period can provide Portland residents and visitors the opportunity to learn how they can make a difference, and become effective stewards for the environment.

The role of the private sector cannot be underestimated, because without their involvement, we cannot move the environment agenda forward.

And, I am delighted that Bayer USA is here with us today. Their support of World Environment Day, and UNEP's youth program in particular, is an excellent example of corporate social responsibility.

How we celebrate World Environment Day is limited only by our imagination.

In addition to local and national governments enacting environmental laws, poets and singers have written inspiringly about the environment and the related-theme.

Academia have organized symposia to discuss problems and offer solutions.

Schools have challenged each other to see how well and how quickly they can green their environment.

Zoos and botanical gardens have organized activities to demonstrate the relevance of flora and fauna to our daily lives.

We also need the media's involvement.

We need you to cover not just World Environment Day activities, but the broader environment story.

We need the support of the entire community to help make World Environment Day in Portland the biggest and best event ever in North America.

I would like to take this opportunity to mention that it is my initial conversation with one of Portland's own – Anne Nelson of the Bureau of Environmental Services – that has led us to this moment. I acknowledge her role in making WED in this beautiful city possible.

On behalf of UNEP, I congratulate the leaders and the citizens of Portland for being on the cutting edge of sustainability.

Cities around the world can learn from your best practices, and perhaps we can work together to make this happen.

Once again, Mayor Hales and City Council members, I extend to you our heartfelt appreciation for your support.

And now, it gives me great pleasure to introduce Lauren Trocano, Director of Corporate Social Responsibility for Bayer Corporation in the United States.

Theme: Water: Where Does It Come From?

The International Children's Painting Competition on the Environment (ICPC) is organized by the United Nations Environment Programme (UNEP), the Japan-based Foundation for Global Peace and the Environment, Bayer Corporation and Nikon. It has been held annually since 1991 and has received more than 3 million entries from children in more than 150 countries.

The ICPC is part of UNEP's TUNZA programme for children and youth. "TUNZA" means to treat with care and respect in Kiswahili and is a wide-ranging programme to involve children and young people in environmental issues. The theme for this year's competition is "Water: Where Does It Come From?"

Students are invited to produce original artworks that focus on water as the source of all life on Earth. In designing their paintings, students should consider the responsibility we all share to ensure a healthy, secure and sustainable water supply for our communities, environment and economy as our quality of life depends upon it. Without water, there will be no life on Earth – plant, animal or human.

The competition entry deadline is March 15, 2013. The organizers encourage children from around the world to submit their paintings to the UNEP office in their region. The address for the North American region, as well as the other regions, is provided in the Entry Rules and Conditions section.




In addition to the extensive list City staff will be coordinating with neighborhood groups, watershed councils, school groups and environmental organizations, and others will be encouraged to share their environmental activities as part of the calendar. The City will work with these same groups to develop and coordinate a public event celebrating World Environment Day. Finally, as part of this event, with no expense to the City, the International Children's Painting Competition will be exhibited in Portland, with winners receiving a trip to Portland for World Environment Day festivities. This is sponsored entirely through United Nations Environment Programme and Bayer Corporation, who is the major underwriter of the World Environment Day youth events.

I. RECOMMENDATION

Declare the City of Portland host of World Environment Day, June 5, 2013.

II. BACKGROUND

World Environment Day global celebrations are commemorated each year on June 5th in more than 130 countries around the world. World Environment Day is one of the principal vehicles through which the United Nations stimulates worldwide awareness of the environment and enhances political attention and action. The global celebrations are held in a different country every year, and each region selects a host city. The United Nations Environment Programme Regional Office of North America has invited Portland to host World Environment Day 2013.

III. FINANCIAL IMPACT

Minimal financial impact: short-term utilization of BES Willamette Watershed staff for coordination at 0.5 FTE (February – early June 2013) (approximately \$18,000) + .1 FTE total (\$5,000) from other Bureau representatives combined if available. Goal is to utilize existing resources only. Outreach will rely primarily on existing City and partner outreach mechanisms including websites, calendars, listserves, media, and flyers, announcements at events, etc.

VI. LINK TO CURRENT CITY POLICIES

Acceptance of this invitation provides further opportunity to link City policies and accomplishments, thus far pursuant to those policies including:

- Portland Watershed Management Plan, adopted by Council March 2006 that describes actions for watershed health, including an aquatic and terrestrial enhancement strategy to protect and restore natural stream functions.
- Portland Invasive Plant Strategy, adopted by Council August 2009 defines a 10-year management plan for plants and an assessment for animal invasive species that is viewed as a model program by other cities.
- Portland's Green Street policy, adopted by Council in April 2007 that directs City Bureaus and agencies to cooperatively plan and implement Green Streets as an integral part of the City's maintenance, installation and improvement program for its infrastructure located in the City's right-of-way. Council acknowledges Green Streets and successful tool to meet regulatory mandates for stormwater, protect investments in stormwater pipe infrastructure, improve community livability, provide wildlife habitat and promote connectivity between neighborhoods.
- Portland's Bicycle Master Plan, adopted by Council February 11, 2010, represents Portland's great strides towards linking land use, transportation, public health, environmental goals and carbon emissions reductions.
- City of Portland and Multnomah County Climate Action Plan, adopted by Council in October, 2009. This policy directs the City to lessen carbon emissions and outlines steps to do so. The City is renowned for reducing carbon emissions while other cities levels are rising.
- Urban Food Zoning Code Update, adopted by Council June 13, 2012. The update allows better access for all Portlanders to healthful, affordable food and gardening space.
- Portland Plan, adopted by Council April, 2012. The Portland Plan presents a strategic roadmap to help our city thrive into the future, and includes the Healthy Connected City Strategy that emphasizes environmental health, which provides foundation for current comprehensive planning efforts.
- Citywide Tree Policy and Regulatory Improvement Program, adopted by Council April 2011, to enhance urban canopy through development and redevelopment.
- Additionally, Portland's green infrastructure elements, composting program, community gardening, recycling, weatherization, biking and walking infrastructure, and educational work can and will be highlighted.
- We have quite a story to tell in terms of all Portland that has already achieved and how we continue to work collaboratively with our partners to meet these forward-thinking policy and program goals today, and in years to come.

VII. CITIZEN PARTICIPATION

The citizens of Portland will be invited to participate in and develop a myriad of environmentally-focused activities such as tours, workshops and restoration events hosted by the City and its partners from Earth Day on April 22nd, through World Environment Day on June 5th. It is an opportunity for the City's work and that of all Portlanders to be featured under one umbrella of World Environment Day. In addition to the extensive list staff has compiled of already planned events citywide during that time, City bureaus, agencies, neighborhood groups, watershed councils, school groups, environmental organizations, individuals and other groups will be able to share their environmental work as part of the calendar. This is meant to be a collaborative process and celebration of all Portlander's great efforts that led to this distinction. Through the coming months, in collaboration with the community, staff will coordinate a public event celebrating World Environment Day on June 5th. Finally, as part of this event, with no expense to the City, winners of an International Children's Painting Competition will be exhibited in Portland and the winners will receive a trip to Portland. This is sponsored entirely through United Nations Environment Programme and Bayer Corporation. There is a special entry section and prize for Portlanders! Portland's World Environment Day website will be linked to United Nations Environment Programme's global and regional websites for global

exposure. World Environment Day's growing global outreach was evidenced by the more than 200,000 blogs that were written on World Environment Day, 43 million impressions on Facebook, and around 14 million on Twitter in June 2012.

VIII. OTHER GOVERNMENT PARTICIPATION

This event is sponsored through the United Nations Environment Programme. As noted in VI. above, the resolution will mark the start of an extensive public outreach effort to bring awareness to both the honor of hosting World Environment Day, and an invitation to participate in and help create the series of events bridging Earth Day, April 22, 2013 to World Environment Day, June 5, 2013. In addition to multiple City of Portland bureaus, potential partners will include: Metro, Tribal Nations, Multnomah County, East and West Soil and Water Conservation Districts, etc.
