## ORDINANCE No. 185890

\*Authorize the Director of the Bureau of Environmental Services to enter into Intergovernmental Agreements for the Portland Loo (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- The City of Portland has developed the concept and design of the Portland Loo 1. public restroom modular units. The City has successfully deployed six of these units across the downtown core area, and has already produced and sold one unit to the City of Victoria, Canada. The City desires to continue making units available for sale to other municipal entities, businesses, and individuals.
- Through a budget note contained in the FY2012-2013 Adopted Budget, City 2. Council directed the Bureau of Environmental Service to assume management of the Portland Loo Program effective July 1, 2012.
- 3. In order to effectively manage this program and to accept and timely process orders and consummate sales to other municipal entities, businesses, and individuals, the Bureau of Environmental Services needs the authority to execute routine intergovernmental documents covering Loo sales transactions.

## NOW, THEREFORE, the Council directs:

- That the Director of the Bureau of Environmental Services or his/her designee is a. authorized to execute intergovernmental agreements necessary to the commitment to and completion of sales transactions for the Portland Loo.
- The Council declares that an emergency exists because a current sale is pending Section 2. and awaiting signatures. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
