## **TO THE MAYOR:**

Transmitted herewith is the Certificate of Completion, Acknowledgement, Release & Certification, for the SW Sam Jackson Park Road and Broadway Drive Emergency Landslide Mitigation projects.

As authorized by Ordinance No. 184709, the Emergency Construction Contract No. 30002144 was signed on July 7<sup>th</sup>, 2011 for SW Sam Jackson Park Road. Work was completed by September 2<sup>nd</sup>, 2011 for a cost of \$789,281.68 by Tri-State Construction.

As authorized by Ordinance No. 184709 Construction Change Order #1, dated Sept 16<sup>th</sup>, 2011, amended the original contract to add Landslide Mitigation work on SW Broadway Drive. That additional work was completed by Dec 9<sup>th</sup>, 2011 at a cost of \$618,728.76.

The final contract amount was \$1,408,010.44 which is 78 % over the original contract amount. The contractor has been paid in full. This project had 28 % participation by Minority, Women and Emerging Small Business sub-contractors.

It is recommended that the Council approve the Certificate of Completion and accept the completed projects.




