To Portland City Counsel

My name is Timothy O Youker I was born in Portland 57 years ago. I have been in the graphic arts industry for over 30 years as an Offset Printing Press Operator, Typesetter, Printing Sales, and Management. I was the owner of a commercial printing business on SE 89th Stark st for 18 years.

I was hired as a Journeyman Printing Press Operator 2 (rephotograph operator 2) working at Printing and Distribution P/D for the City of Portland for about 3 years, I went on medical leave in 2010. While working at P/D I noticed many things that could be changed to increase business to help the public and City. I have gone through the chain of command with no results at all, I am asking the City Counsel to Make the necessary changes in the policy in the way every department within the City of Portland order all printed materials through P/D, I was informed by management at P/D Departments within the city did not have to order through P/D. Lets OPEN P/D To all non-profit businesses in the metro area for long term or 6 months to a year test. Retail advertising can be very expensive in getting the word out to the public about all the programs and help available to the general public. Non-Profit Business able to use the city print-shop would be able to help everyone. Having an active sales personal visiting every customer of P/D, this would also increase the amount of work coming in. My job as an rephotograph operator 2 was not supported by an rephotograph operator 1, as it should have been, according to the employee handbook. P/D is not open to Volunteers or Interns attending school can this policy be changed also? Would City Counsel, P/D management consider visiting a large secured commercial Printing facility Direct Marketing Solutions, DMS I believe is one of the top commercial print shops in Portland Or. I have worked with the same outside printing vendors as P/D. and many more printing and letterpress vendors in Portland, from what I saw P/D was paying retail on some jobs instead of wholesale, all vendors should be re-evaluated, low bids awarded to vendors. I did fill out papers at the Authors Office Because it has been many years since P/D has been audited. Because of my back problem and being on medical layoff from the city, returning to my job as a press operator may be a problem working in management or Volunteer my time sharing what I have learned the past 30 years. 
