ORDINANCE No. 185904

*Amend Legal Services Agreement with Cascadia Law Group for outside counsel (Ordinance; amend Contract No. 34620)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Environmental Services required the services of outside legal counsel to provide legal advice regarding the Portland Harbor Superfund Site.
- 2. The law firm of Cascadia Law Group agreed to provide these services as they relate to natural resources restoration, insurance and early cleanup issues.
- 3. It is necessary to increase the amount of the agreement to provide final payment for services provided under this agreement.

NOW, THEREFORE, the Council directs:

- a. The City Attorney is authorized to extend Legal Service Agreement No. C34620, which provides representation by outside counsel, in an additional amount of \$80,000, bringing the total of this agreement to \$2,655,000.
- b. If applicable, the provisions of City Code Chapter 5.68 are waived.
- c. The Mayor and Auditor are authorized to draw and deliver checks when demand is present and approved by the City Attorney.

Section 2. The Council declares that an emergency exists in order to pay for legal services necessary in the matter of the Portland Harbor Superfund Site; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
