### RE: Amendment request for Council Agenda Items 969-971

It is necessary to rename the project and referenced terminology in the Ordinance, exhibits, and resolutions from Cully Main Street and Local Street Plan to the Cully Commercial Corridor and Local Street Plan. The name change is intended to prevent any potential confusion with Portland's Main Street Program. Therefore, the new titles for the Ordinance and Transportation Resolution as amended will read:

Amend Portland's Comprehensive Plan Map and Zoning Map for properties along or near the Cully Commercial Corridor (Ordinance; amend Title 33, Comprehensive Plan Map)

Adopt the transportation recommendations contained within the Cully Commercial Corridor and Local Street Plan as the strategy for developing the transportation system in the Cully Neighborhood (Resolution)

The title for the resolution on using Cully as a case study to address gentrification and displacement does not need to change.

# a) What impacts are anticipated in the community from this proposed Council item?

New development and redevelopment projects may happen along the Cully main street area over time as well as some improvements to the local street system and walking/biking routes to local schools. There will be positive impacts of new businesses serving the current commercially deficient Cully neighborhood; and along with new sidewalks, street connections, etc. as street improvements happen over time. However, there is some community concern that these investments will increase property values, benefit new residents or business people from outside of Cully, and cause the involuntary displacement of lower income residents and businesses in this racially and ethnically diverse modest income neighborhood.

### b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

Cully Assoc. of Neighbors, 42<sup>nd</sup> Ave Business Assoc, Cully Blvd. Alliance, Hacienda CDC, Verde, Native American Youth and Family Services, local schools, parent and resident groups, Multnomah County, Portland Public Schools, Trimet, Portland Commission on Disability, bicycle and pedestrian bicycle advisory groups, faith organizations, local property owners and residents.

Some of these groups were represented on a Project Working Group, presentations were made and input received at a variety of group/organization meetings, these groups were invited to attend and participate at the 3 major public events for the project and the public hearings.

Staff attended and participated at Hacienda Latino and Somali parent groups, and discussed the project with the Portland Commission on Disability and its Accessibility and Built Environment Committee.

Some materials and all event announcements were produced in Spanish and distributed to Latino businesses and residents. Every major event included Spanish interpretation and child care, both were well used. A PCC English for Speakers of Other Languages class of local residents also participated at major project events.

### c) How did public involvement shape the outcome of this Council item?

Staff developed project products, which were first vetted by the Project Working Group and then the broader public at major events. The proposals were revised based on public input.

Project team designed the public involvement for this project and the project team sought input on specific events and activities from the Project Working Group through the process. The project team implemented the public involvement events and activities.

City bureau staff from BPS, PDC, Bureau of Housing, and the Office of Equity and Human Relations, will be working on policies and strategies related to gentrification and displacement with interested community organizations. These bureaus will also be compiling, updating, and monitoring historic, current and future demographic, housing and market data for the Cully neighborhood. This will assist all partners in developing and modifying policies and strategies over time as necessary.

The BPS NE District Liaison will continue to work with the Cully community to stay informed on neighborhood-related matters including changes to the main street area and infrastructurerelated improvements.

PBOT staff will continue to work with property owners and community members as transportation improvements are implemented.

7. What Individuals or Groups Are or Would Be Opposed to This Ordinance? Supportive? No opposition has been identified. At the May 22, 2012 Planning and Sustainability Commission (PSC) meeting, staff presented the proposed Cully Main Street and Local Street Plan. The staff recommendations received unanimous support by the PSC.

#### 8. How Does This Relate to Current City Policies?

The proposed plan will significantly enhance the multimodal transportation system in the Cully Neighborhood. The Plan advances the City's adopted transportation goal, in the Comprehensive Plan and Transportation System Plan, by providing a wider range of transportation choices; reinforcing the livability of neighborhoods; and lessening the reliance on the automobile while maintaining accessibility.

#### 9. Community Participation:

There was extensive public participation in the development of the Plan. A Project Working Group (PWG), made up of diverse community stakeholders, met at five strategic times during the process to review and comment on staff generated materials and public process. Their comments were invaluable to staff and helped shaped .

Several other groups were engaged as part of the plan development, including the Cully Assoc. of Neighbors, 42nd Ave Business Assoc., Cully Blvd. Alliance, Hacienda CDC, Verde, Native American Youth and Family Services, local schools, parent and resident groups, Multnomah County, Portland Public Schools, Trimet, Portland Commission on Disability, bicycle and pedestrian bicycle advisory groups, faith organizations, local property owners and residents. Project staff attended and participated at different community meetings to raise project awareness, solicit participation, and gather comments from folks on project-related matters.
