

ORDINANCE No. 185933

*Authorize a contract to replace four street sweepers for use by the Bureau of Transportation for \$908,040. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The CityFleet Division of the Bureau of Internal Business Services replaces all City vehicles based on an annual replacement plan.
2. CityFleet has reviewed the standard replacement schedule and the condition of the Bureau of Transportation street sweepers.
3. It has been determined that four street sweepers need to be replaced for Bureau of Transportation - Exhibit A attached.
4. The cost of these vehicles is \$227,010 each, or \$908,040 for four Tymco street sweepers.
5. The City now desires to purchase these vehicles.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to enter into the contract and any subsequent amendments on behalf of the City for the purposes identified in Section 1.
- b. The Commissioner and Auditor are hereby authorized to pay for said purchases from the CityFleet replacement funds.

Section 2. The Council declares that an emergency exists because delay in proceeding with the purchases would result in additional expense and unnecessarily deprive the City of the use of these vehicles at an early date; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
