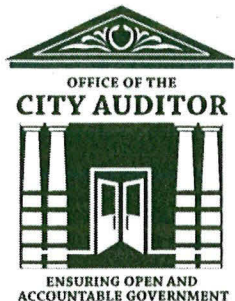
This timely appeal is made pursuant to City Code 16.40.580.
