

ORDINANCE No. 186010

*Accept and appropriate a grant in the amount of \$47,189 from the State of Oregon, Youth Development Council to provide a Gang Impacted Family Team Coordinator and a public service phone number (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. The Mayor's Office, Office of Youth Violence Prevention applied to the State of Oregon, Youth Development Council for a grant in the amount of \$55,687.28 to provide a Gang Impacted Family Team (GIFT) Coordinator and a public service phone number on March 8th, 2013; and
2. The State of Oregon, Youth Development Council has notified the City of Portland that it will award a grant to provide a Gang Impacted Family Team (GIFT) Coordinator and a public service phone number through the Mayor's Office, Office of Youth Violence Prevention in the amount of \$47,188.80;
3. The State of Oregon, Youth Development Council grant requires matching funds in the amount of \$8,498.84, which the Office of Youth Violence Prevention has available in its FY 2012-13 Revised Budget.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the State of Oregon for the Youth Development Council (YDC) in the amount of \$47,188.80.
- b. The FY 2012-13 budget is hereby amended as follows:

GRANTS FUND

Fund – 217

Business Area – MY

Bureau Program Expenses – \$11,800

- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Mayor of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by the State of Oregon, Youth Development Council for Title II Formula grant, CFDA # 16.540, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that

increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily inhibit the City's ability to perform the activities authorized by the grant. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
