ORDINANCE NO. 186013

* Authorize application to the Oregon Parks and Recreation Department for a grant in the amount of \$144,295 for Marshall Park Play Area Rehabilitation Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Oregon Parks and Recreation Department is soliciting projects for grant funding under the Local Government Grants program which funds projects with special attention to the rehabilitation of park assets.
- 2. Portland Parks & Recreation is seeking funding through this Local Government Grants Program to replace and relocate unsafe playground equipment in Marshall Park away from Tryon Creek and move it beyond the floodplain. This will improve access to the replacement playground as well as the natural area, along with increasing stream-side habitat through plantings and enhance educational and recreational benefits through interpretive features.
- 3. Local match in the amount of \$139,295 will be provided by funds from systems development charges.
- 4. The Friends of Marshall Park have raised \$5,000 in support of the project and have applied for additional funds. If their grant seeking is successful the funds raised will reduce the system development charges applied to the project.

NOW, THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to make application to the Oregon Parks and Recreation Department for a grant in the amount of \$144,295.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because delay in applying for the grant jeopardizes the proposals' chance of being considered for or receiving funds; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
