Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) has need of continuing professional engineering services provided by BergerABAM for additional design and construction phase services for the Skidmore and Safeway Wastewater Pump Station Remodels, Project Nos. E10291 and E10292.
- 2. BergerABAM was selected to provide professional design engineering services under Contract No. 30002704, effective April 13, 2012, with an expiration date of May 1, 2017.
- 3. The attached Amendment No. 2 is for additional work in the amount of \$21,498 for a new, notto-exceed contract amount of \$464,431. The additional work provides design and construction phase services for additional geotechnical investigation, discharge manhole rehabilitation, and relocation of a parking lot light.
- 4. M/W/ESB participation after the authorization of this contract amendment will be \$106,973. 23.0% of the total amended contract amount of \$464,431.
- 5. The increased cost for this contract amendment is \$21,498. Funds are available in the Sewer System Operating Fund, FY 2012-13 Budget, Bureau of Environmental Services, WBS Elements E10291 and E10292.

- The Commissioner in Charge is authorized to execute a contract amendment with a. BergerABAM for the purpose described in Section 1, in the amount of \$21,498.
