

ORDINANCE No.

\* Amend subrecipient contract with JOIN to add \$30,000 for the revised total contract amount not to exceed \$1,344,757 for placing chronically homeless veterans into housing (Ordinance; amend Contract No. 32000781).

The City of Portland ordains:

Section 1. The Council finds

1. The City of Portland passed Ordinance No. 185466 on June 27, 2012 authorizing 20 subrecipient contracts, including subrecipient contract #32000781 with JOIN for the provision of services in support of ending homelessness and providing affordable housing.
2. JOIN has agreed to provide outreach, housing placement, and retention services to people who are experiencing homelessness as well as chronic homelessness.
3. Portland Housing Bureau desires to fund JOIN an additional \$30,000 for placing chronically homeless veterans into housing.
4. The additional funding for JOIN is included in the City's FY2012-13 General Fund.

NOW THEREFORE, The Council directs:

- a. The Bureau Director and City Auditor are hereby authorized to amend subrecipient contract No. 32000781 with JOIN to add \$30,000 for the revised total contract amount not to exceed \$1,344,757 in accordance with the amendment attached as Exhibit A.
- b. The Bureau Director and City Auditor are hereby authorized to draw and deliver warrants chargeable to the FY 12-13 budget when demand is presented and approved with the proper authority.

Section 2. The Council declares that an emergency exists because a delay in funding would unnecessarily delay JOIN's ability to provide the services. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
