#### 7. BACKGROUND/ANALYSIS

This claim arises from a sewer backup that occurred in November 2012. A PBOT Maintenance Operations crew began sewer repair work on November 16, 2012 in the street in front of the claimants' home at 5607 SW Seymour Street. Before the project was completed, rock and debris from the sides of the excavation fell into the hole and blocked the sewer lateral, which resulted in a sewage backup into the claimants' finished basement.

Risk Management has negotiated settlement with the homeowners for the total sum of \$15,000. We have advanced a total of \$10,000 (\$5,000 to each claimant). This ordinance is to obtain approval for payment of the remaining \$5,000 settlement amount.

#### 8. FINANCIAL IMPACT

Approval of the settlement would result in a total payment of \$15,000 from the liability fund.

Approve settlement of Jennifer & John Jennings property damage claim in the sum of \$15,000.
