GO Bond Independent Citizen Committee (Report)

As the Chief Administrative Officer with responsibilities for GO Bond Fund, I am pleased to convey the first annual report of the GO Bond Independent Citizen Committee (ICC), attached as Exhibit A.

The ICC is now in full operation and has been meeting quarterly since March 2011. The following processes and organizational structures have been put in place to ensure timely and accurate information to the citizen members of the ICC:

- Project oversight committees (POC) are established for the four projects receiving funding from the GO Bond.
- City project staff prepares standard, and quarterly status reports, then submits them for review and approval by their respective Project Oversight Committees (POC) who then submit them to the ICC.
- The ICC meets quarterly with City project staff and POC members to discuss the projects' financial and physical progress and any issues or concerns. These meetings will continue quarterly until bond proceeds are expended.
- The ICC prepares quarterly reports for the CAO, summarizing GO bond fund status and the respective progress of the four public safety projects funded by the bond.
- The ICC prepares an annual report for the CAO to submit to City Council.

This second annual report of the ICC provides a summary of the origin and development of the GO Bond ICC, status of the GO Bond Fund, and status of the four public safety projects.

I recommend that Council accept the report.
