



## Linda Robinson

### Name one interesting thing about your relationship with Parks:

Oh my, where to start? One thing that most people don't know is that I served on SPLAT for nearly two years – the skatepark siting task force (206-2008?). SPLAT stood for Skatepark Leadership Advisory Team. Also, I learned to ride a bike, for the first time, at age 65 after taking the senior biking class at Willamette Park, and now I ride regularly on the Springwater Corridor and other off-road bike paths. But my biggest involvement with Parks is the work I've done on developing Gateway Green, starting in December 2005 – and culminating (whew hope!) in the development of that new park within the next year or two!

### Tell us why you love parks:

I grew up in a rural area that is now a large Gresham subdivision. Our 4-acre mini-farm included a huge garden, a small fruit orchard, a few farm animals, and a gulley with a spring which is the headwaters of Heiney Creek, a small tributary of Johnson Creek. I don't think there were any neighborhood parks in the area. I recall visiting a city park (a park with play equipment and a pool) only twice -- once, when my aunt took us to Sellwood Park while my mother was in the hospital giving birth to my baby brother, and our 7<sup>th</sup> grade end-of-the-year picnic at Peninsula Park (as there were NO parks in Gresham). Instead, my siblings and I spent hours playing in the gulley and the stream behind our house. Since we lived near the Columbia Gorge, we did visit many of the natural areas and state parks in the Gorge – to hike and/or picnic. And we occasionally spent a weekend camping at a state park on the Oregon coast. Livability in the urban area depends on maintaining that connection with nature, and on maintaining opportunities for active and passive recreation in a natural setting.

### Tell us why you joined the Parks Board:

Because Mike Houck persuaded me to apply – and because I'm nosey, always wanting to know more about "what's going on". Also, I had been involved with park issues/events for many years, starting in the early 1990's with the creation of the Metro Greenspaces program. I also felt very strongly that park-deficient East Portland should have representation on the Parks Board.

## YOUR SHORT PROFESSIONAL BIO: Where you work or what you do for a living and the part of town you live in.

I live in the Hazelwood neighborhood in East Portland. After working for 13 years as a research assistant/data analyst at PSU and PPS, I made a significant mid-life career change, working at East Multnomah SWCD, creating, then managing the Naturescaping for Clean Rivers program – a public outreach program focused on pollution prevention. I worked there until I retired in 2002.
