

ORDINANCE No. 186048

Authorize contract with Harper Houf Peterson Righellis, Inc. and provide payment for design services of the SE Hawthorne Sewer Improvements Project No. E08668 for \$422,441 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services pursues design and construction of projects to provide sewage collection to accommodate Portland's current and future needs. The bureau's Tabor to the River Program conducts this work while promoting healthy ecosystems in our watersheds.
2. The project involves work with approximately 3,850 linear feet of combined sewer pipe that has insufficient capacity or poor structural condition. An additional 900 linear feet of new sanitary sewer pipe is included to meet current sewer service standards. Finally, the project contains approximately 12 vegetated stormwater (a.k.a. green street) facilities.
3. There is interest, citywide, to construct green street facilities.
4. A consultant selection process has been conducted and Harper Houf Peterson Righellis, Inc. was selected to provide Design Services for this project.
5. There is 14% M/W/ESB participation on this contract.
6. The estimated cost is \$422,441. Level of confidence is high. Funds are available in the Sewer System Operating Fund, FY2012-13 Budget, Bureau of Environmental Services, WBS Element E08668

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute a contract with Harper Houf Peterson Righellis for the purpose described in Section 1, in the amount of \$422,441.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


