The proposed Ordinance requests to transfer to PPS up to \$450,000 of PP&R System Development Charge funds and \$52,000 from the PP&R Sports Work Group Fund. In addition, the proposed Ordinance requests to expend up to \$20,000 of PP&R System Development Charge Funds to be used for PP&R permitting, design and construction staff oversight.

The annual O&M for the synthetic turf field is estimated to be \$14,226.

A Grant High School parent group, Friends of Grant Athletics (FGA), has been instrumental in conducting community outreach and raising funds to improve the outdoor playing services at Grant Park and Grant High School. Since 2005, Portland citizens have been actively involved in review of the possible improvements, community outreach, fundraising and advocacy for this project. The proposed improvements were presented to Portland City Council in April 2010. On April 21, 2010, Portland City Council approved Ordinance 183711 to authorize the Commissioner in Charge of PP&R to execute a Memorandum of Understanding between PP&R, PPS and FGA to outline roles and responsibilities of the parties to restore and improve sports fields and the track at Grant Park and Grant High School.

a) What impacts are anticipated in the community from this proposed Council item?

The first improvements to be made at Grant Park will include replacement of a grass field with all-weather turf and restoration of the track

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

Beginning in 2001, Grant High School (GHS) parents and supporters began seeking ways to enable GHS football games to be played on a "home" field, and to upgrade the quality of the athletic facilities used for youth athletics at the park and school. In 2005, the FGA, with PPS and PP&R concurrence, began a formal public involvement process that included a citizen advisory committee, surveys, community meetings, and open house presentations.

c) How did public involvement shape the outcome of this Council item?

In 2006, PPS and PP&R adjusted the project scope in response to community concerns, and in 2007, PPS and PP&R eliminated project elements. In 2008, PP&R and PPS jointly hosted a community open house to share the new design concept based on community input.

In 2010, PPS, with PP&R and FOGA, selected Dull Olson Weekes Architects to develop the design drawings for the site; the design process was completed in May 2011. Construction is dependent on successful fundraising efforts to cover the cost of the project.
