This ordinance will increase the amount of compensation authorized under the construction contract in order to reimburse JW Fowler for extra construction expenditures requested by Portland Parks & Recreation (PP&R) to complete Phase 1B of the South Waterfront Central District Greenway. These extra expenditures total \$1,764,300, which in addition to Change Orders already executed, brings the total contract value to \$7,028,787.29, an overall increase of 74.16%. PP&R investigated rebidding the Phase 1B work. Staff determined, however, that the current contractor would provide the best value for the City, given their strong performance to date and the complexity of the work.

This Ordinance is an administrative action to adjust the contract amount for an existing project that has already had extensive public involvement. Additionally, an update on the project is sent out twice a month to residents, businesses, community organizations and local publications.

 - a) What impacts are anticipated in the community from this proposed Council item?

The community is very invested in the completion of this project. This ordinance may increase concern about when Phase 2 of the project will proceed.

Project funding has been a briefing topic with the community since we began work. The community is aware that we are seeking additional funds to complete the work. With each update, PP&R has been transparent about progress toward identifying funds to complete the entire project. This Ordinance will be mentioned in the updates as will future contract amendments that may be needed.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

An extensive public participation process began in 2003 with the master planning process for the South Waterfront Greenway as a whole and continued with a focused Advisory Group process in 2007 and 2008. Since then, a public information plan has kept the large group of stakeholders informed about progress via website updates, e-mail blasts supplemented by occasional meetings, and Facebook posts. PP&R visited the SOWA neighborhood 4 times in 2012 as well as sent out project updates every 2-3 weeks throughout the duration of 2012 construction, and has begun this process again for 2013. PP&R has already held two public meetings in 2013.

Stakeholders contacted include, but are not limited to: South Portland Neighborhood Association, South Waterfront Community Association (e-Current + Nature and Greenspaces Committee), e-mail contact lists developed during public meetings, Design Commission, Parks Disabled Advisory Committee and the Audubon Society. The Native Advisory Committee for PP&R has also been involved.

c) How did public involvement shape the outcome of this Council item?

Feedback from the public has clearly indicated the public's commitment to completion of this project. Using feedback from the community received during our regular project updates, the Council item has been worded as clearly as possible, so that they have a full understanding of the issue at hand.
