

ORDINANCE No. 186138

Authorize a contract with Parametrix, Inc. for professional services for the design of the Riverview Forcemain Replacement Project No. E08866 for \$268,095 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has need of a consulting engineering firm to provide professional services for the Riverview Forcemain Replacement Project No. E08866..
2. Consultant selection has been conducted in accordance with Chapter 5.68 of the Code of the City of Portland (RFP BES142). The consultant selection committee recommends that Parametrix be retained to provide the required professional engineering services.
3. The estimated cost is \$268,095. Funds are available in the Sewer System Operating Fund, FY 2014 Budget, Bureau of Environmental Services, WBS Element E08866. M/W/ESB participation is \$65,088 or 24.3% of the total contract amount.

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute a contract with Parametrix for the purpose described in Section 1, in the amount of \$268,095.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
