#### 1) Legislation Title:

Authorize the Director of the Bureau of Environmental Services or his designee to enter into agreements with private property owners for rehabilitation of private sewer service laterals to remove inflow and infiltration from the public sewer conveyance and treatment system. (Ordinance)

#### 2) Purpose of the Proposed Legislation:

To meet the interim requirements of the Mutual Agreement and Order (MAO) WQ/M-NWR-11-091 with the Oregon Department of Environmental Quality (DEQ) to reduce Rain-Derived Inflow and Infiltration (RDII) to the system in order to eliminate sanitary sewer overflows on Dewitt St in the Burlingame sewer basin, and to reduce the infiltration of stormwater into public sewers conveyance and treatment system in the Fanno Creek and Burlingame Sanitary Sewer basins. The Participation Agreement allows BES to enter private property and perform rehabilitation work on private laterals as part of the pilot projects implementation.

RE: Ordinance authorizing the Bureau of Environmental Services to enter into agreements with private property owners for rehabilitation of private sewer service laterals to remove inflow and infiltration from the public sewer conveyance and treatment system.

Requested Council Hearing Date: June 26, 2013

#### I. RECOMMENDATION

Approve the ordinance authorizing the Director of the Bureau of Environmental Services or his designee to enter into agreements with private property owners for rehabilitation of private sewer service laterals to remove inflow and infiltration from the public sewer conveyance and treatment system.

#### II. BACKGROUND

BES has performed extensive analysis of its sanitary sewer collection system and determined that RDII causes significant problems in southwest Portland's sanitary sewer basins, most significantly in the Fanno Creek and Burlingame sanitary basins as documented in the "Recommended Plan for Fanno Creek and Burlingame Sanitary Basins," March 21, 2012.

BES has initiated an RDII program to reduce the inflow of stormwater from the sanitary system in the Fanno Creek, Tryon Creek and Burlingame sanitary sewer basins. This program has recommended pilot projects to investigate the effectiveness of various methods and approaches to resolving RDII from private property prior to developing a larger basin-wide program.

In 2012 Council adopted Resolution 36977 recognizing the negative impacts of Rainfall Derived Infiltration and Inflow (RDII) and endorsing implementation of RDII pilot projects.

These agreements with private property owners will enable the rehabilitation of private sewer service laterals.

#### III. FINANCIAL IMPACT

BES staff time will be used for outreach efforts and administrative processing of the agreements. BES will pay to record the easements granted as required by the agreements. BES will fund and construct private service rehabilitation efforts on private property using funds available in the current & future years requested Sewer System Operating Fund Budget. In addition, because the agreements require the City to indemnify the property owners, BES could be required to pay legal and other costs associated with that obligation. The source of funding is BES revenue from rates.

#### IV. LEGAL ISSUES

The City Attorney's Office foresees no legal issues with the use of these agreements for these projects because property owner participation will be entirely voluntary and because the projects are not anticipated to conflict with City Charter or Code provisions.

#### V. CONTROVERSIAL ISSUES

Ratepayer funds will be used to rehabilitate or replace a certain number of private sewer laterals. However, BES has determined that these projects represent a cost-effective method of reducing excessive stormwater in the public sewer system and complying with the City's obligations under the MAO.

#### VI. LINK TO CURRENT CITY POLICIES

These projects support an asset-management approach to reducing long-term risk to the environment and to the City.

#### VII. CITIZEN PARTICIPATION

Property owners in the targeted project areas will be provided with background information by mail and canvassed one-on-one in order to have direct conversations about participation and entering into these agreements.

#### VIII. OTHER GOVERNMENT PARTICIPATION

Clean Water Services (CWS) has an interest in the BES RDII program. Reduction of RDII in southwest Portland will reduce the amount of wet weather flow directed to their system and is a requirement of our cooperative agreement.

Oregon DEQ is involved in the oversight of the MAO with BES to resolve sanitary sewer overflows in the Burlingame Sanitary Sewer Basin. The Burlingame Sanitary Sewer Basin pilot projects help meet the requirements in the MAO.
