*Authorize Intergovernmental Agreement with Oregon Department of Transportation for the design and construction of I-5 Northbound Ramps at SW Coronado St Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Oregon Department of Transportation (ODOT) will design and construct ramp improvements on the northbound ramps onto I-5 adjacent to SW Coronado Street. The improvements will require ODOT taking over a portion of City right-of-way and will require continued maintenance work after construction is complete.
- 2. ODOT will submit a copy of the plans and specifications to the City of Portland Bureau of Transportation (PBOT) for review and concurrence prior to construction. PBOT's review and concurrence is for the purpose of future maintenance of the project.
- 3. ODOT will, upon City's review of final plans, prepare the contract and bidding documents, advertise for construction bid proposals, award all contracts, pay all contractor costs, furnish all construction engineering, field testing of materials, technical inspection, and Project manager services for administration of the contract.
- 4. There is no cost associated with this project since ODOT will be doing all the work with State funds.

NOW, THEREFORE, the Council directs:

a. That the Mayor and the Auditor are authorize to enter into an Intergovernmental Agreement with ODOT for the design and construction of I-5 Northbound Ramps at SW Coronado Street Project, in a form similar to the contract attached as Exhibit A.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the ODOT's ability to perform the activities authorized by the agreement; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
