ORDINANCE No.

* Authorize an Intergovernmental Agreement with Multnomah County to provide outpatient treatment and supportive housing to chronic offenders identified by the Services Coordination Team (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The chronic recurrence of crime diminishes neighborhood livability and negatively impacts the community's perception of safety.
2. There is a causal relationship between substance abuse and the commission of crime.
3. If housing and treatment programs were more available for those offenders with the greatest need for and potential to benefit from treatment, a decrease in related crimes is predicted.
4. It is most cost effective to purchase residential treatment beds with non-profit organizations through an arrangement with Multnomah County; since these contracts and mechanisms for monitoring services already exists.
5. Multnomah County manages a contract with Volunteers of America to provide these housing and treatment services.
6. There is a one-time, General Fund appropriation to support this agreement in the FY 2013-14 Budget.
7. The payment breakdown is as follows:
 - a. Outpatient treatment for up to 25 individuals identified by a member of the Services Coordination Team.
 - b. Supportive housing with treatment for up to 12 individuals identified by a member of the Services Coordination Team.
8. The term is effective July 1, 2013 through June 30, 2014.
9. The cost of this agreement is \$746,000.
10. It is in the public interest that this agreement be executed without delay to prevent a lapse in this beneficial program.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor are hereby authorized to enter into an agreement substantially in accordance with the agreement attached as Exhibit A.


