

ORDINANCE No. 186154

* Amend contract with Standard Insurance Company to provide employee life and long term disability insurance services (Ordinance; amend Contract No. 30000089)

The City of Portland ordains:

Section 1. The Council finds:

1. The Office of Management and Finance, Bureau of Human Resources provides life and long-term disability benefits to eligible employees and desires to amend its contract with Standard Insurance Company as identified in Exhibit A.
2. Standard Insurance Company has been the City's insurance carrier since 1993. Standard has been successful in retaining the contract through the City's competitive bid process and it is in the best interest of the City to extend its current contract.
3. It is deemed appropriate and necessary to extend the agreement with Standard Insurance to provide life and long term disability benefits to City employees through June 30, 2018.

The Health Fund Budget for FY 2013-14 includes appropriations in support of the benefit related contract identified above.


NOW THEREFORE, the Council directs:

- a. The Mayor or the Director of Human resources is hereby authorized to execute the contract amendments and any subsequent renewal during the term of the contract hereto as Exhibit A attached.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver warrants not to exceed the amounts listed the amendment.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in providing benefits to plan participants; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
