ORDINANCE No.

*Authorize upgrade of six sedans to SUV's for use by Police Bureau K-9 Officers for \$80,554 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Council adopted Resolution 35960 to establish a policy for the acquisition of vehicles.
2. Resolution 35960 requires the CityFleet Division of the Bureau of Internal Business Services, to obtain the approval of the City Council before replacement upgrades.
3. The CityFleet Division of the Bureau of Internal Business Services recognizes the need to upgrade six sedans to SUV's to be used by Portland Police Bureau. These SUV's will have larger interiors, increased functionality and the ability to transport heavy payloads for K-9 officers.
4. It has been determined that six sedans need to be upgraded into SUV's for the Police Bureau, Exhibit A attached.
5. The estimated cost of these vehicles is \$80,553.96 for upgrading six sedans into SUV's funded by Police Bureau and CityFleet replacement fund.
6. The City now desires to upgrade these vehicles.

NOW, THEREFORE, the Council directs:

- a. The CityFleet Division of the Bureau of Internal Business Services, is hereby authorized to upgrade these vehicles for use by the Police Bureau, request identified in the attached, Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to pay for said upgrade from the Police Bureau Budget and CityFleet replacement fund.

Section 2. The Council declares that an emergency exists because delay in proceeding with the upgrade would result in additional expense and unnecessarily deprive the City of the use of these vehicles at an early date; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
