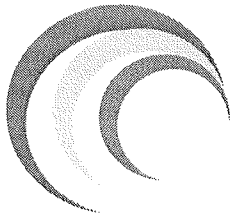

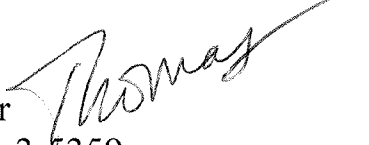

Requested Placement Date: Consent Agenda on June 12, 2013

- I. **RECOMMENDATION.** Grant a franchise to Kinder Morgan Cochin for twenty years.
- II. **BACKGROUND.** Kinder Morgan Cochin LLC, the successor in interest to Chevron Pipeline Company, has requested the City grant it a franchise for a renewed term. Kinder Morgan Cochin and the City reached final agreement on terms and conditions of a 20 year franchise for Kinder Morgan Cochin to use the City Streets to own and operate a Pipeline System. Pursuant to the formal City Charter franchising requirements, the ordinance was published in the Daily Journal of Commerce on April 10, 2013, and a notice published in the Oregonian on April 22, 2013. The Bureau requests the first reading for this ordinance on June 12, 2013, and the second reading on July 17, 2013. Under this schedule, the effective date will be on September 16, 2013.
