I. RECOMMENDATION. Grant a franchise to WCI Cable, Inc., for 10 years.

II. BACKGROUND. The City granted a franchise to WCI Cable, Inc. in 1998. Ordinance 172750. WCI Cable and the City reached final agreement on terms and conditions for a franchise for a renewed term. Pursuant to the formal City Charter franchising requirements, the ordinance was published in the Daily Journal of Commerce on April 17, 2013, and a notice published in the Oregonian on May 9, 2013. The Bureau requests the first reading for this ordinance on June 19, 2013, and the second reading on July 24, 2013. Under this schedule, the effective date will be on September 23, 2013.

III. FINANCIAL IMPACT. WCI Cable will continue to pay franchise fees to the City for its use of the right of way. This revenue is intended for the general fund and is not new revenue.
