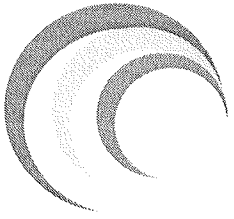

- I. **RECOMMENDATION.** Grant a franchise to SFPP, Inc. for 20 years.
- II. **BACKGROUND.** SFPP, Inc., the successor in interest to Southern Pacific Pipe Lines, Inc., has requested the City grant it a franchise for a renewed term. SFPP and the City reached final agreement on terms and conditions of a 20 year franchise for SFPP to use the City Streets to own and operate a Pipeline System. Pursuant to the formal City Charter franchising requirements, the ordinance was published in the Daily Journal of Commerce on April 10, 2013, and a notice published in the Oregonian on April 22, 2013. The Bureau requests the first reading for this ordinance on June 19, 2013, and the second reading on July 24, 2013. Under this schedule, the effective date will be on September 23, 2013.
- III. **FINANCIAL IMPACT.** SFPP will continue to pay franchise fees to the City for its use of the right of way. This revenue is intended for the general fund and is not new revenue.
