1) Legislation Title: Authorize the Director of the Bureau of Environmental Services to execute Intergovernmental Agreements for the continued implementation of the Innovative Wet Weather Program, not to exceed in aggregate \$300,000.

### 2) Purpose of the Proposed Legislation:

The purpose of this ordinance is to assist in implementing the Innovative Wet Weather Program (IWWP). The Bureau of Environmental Services (BES) has been implementing the IWWP since receiving the first federal appropriation from Congress in 2002. An additional five appropriations were received between 2003 and 2009, totaling \$3.4 million. Over 30 public and private projects were built to support sustainable and innovative green infrastructure projects. IWWP has served as a catalyst for piloting innovations in stormwater management techniques, many of which have now become conventional. It has also provided an opportunity to create many partnerships with private property owners, schools, government agencies and other bureaus.

The IWWP funds are now nearing completion and the grant agreement with the Environmental Protection Agency (EPA) is set to expire at the end of 2014. The ability to engage in Intergovernmental Agreements with other agencies is needed to complete the program.

#### I. RECOMMENDATION

City Council should pass this ordinance to authorize the Director of the Bureau of Environmental Services execute Intergovernmental Agreements to continue the administration of the Innovative Wet Weather Program.

### II. BACKGROUND

Stormwater runoff can impact water quality in rivers and streams. Portland uses green streets, ecoroofs and other green infrastructure to increase sewer system efficiency, and protect water quality, public health and the environment. Green infrastructure keeps stormwater out of the sewer system, filters pollutants, provides habitat and increases neighborhood green space for healthier watersheds.

The Environmental Services Innovative Wet Weather Program (IWWP) promotes stormwater management projects that contribute to healthy Portland watersheds. Between 2002 and 2009, the U.S. Environmental Protection Agency granted the City \$3.4 million to fund over 30 innovative public and private projects throughout Portland that demonstrate sustainable, low-impact stormwater management solutions.

The IWWP program funds are near completion and the ability to execute Intergovernmental Agreements is necessary to fund project implementation. Partners for projects covered under the IWWP funds addressed in this ordinance include other governmental agencies such as Metro, local universities and schools, and Multnomah County.
