

# ORDINANCE No. 186169

\*Authorize grant agreements and Intergovernmental Agreements with twelve non-profit and public entities related to the Community Watershed Stewardship Program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland City Council adopted the Clean River Program on April 6, 1990. In 1995, the Bureau of Environmental Services developed the Community Watershed Stewardship Program (CWSP) to provide grant funds and technical assistance for citizen-led watershed projects. On March 8, 2006, the Council adopted the 2005 Portland Watershed Management Plan which describes actions for watershed health including citizen led activities such as natural area revegetation, education, involvement and stewardship. On May 2, 2012, Council adopted Resolution #36920, reaffirming the City's commitment to watershed health.
2. These grants have been selected for FY13-14: Surfrider - Rain Garden at Peninsula School (\$9,950), King Neighborhood Association - Parking Lot Retrofit (\$10,000), Muslim Community Center Community Garden and Education (\$8,000), Tryon Creek Watershed Council - Stream Restoration Mentors (\$7,660), St. Mary's Ethiopian Orthodox Church - Parking Lot Retrofit (\$10,000), Metropolitan Family Service - SUN Community Garden at David Douglas HS (\$5,500), Groundwork Portland - Green Team Youth Projects (\$5,000), Outgrowing Hunger - East Portland Garden (\$7,990), Wisdom of the Elders, Inc - Native Youth Stewardship & Traditional Education (\$6,000), Micro Enterprise Services of Oregon- Irvington Covenant Rain Garden and Art (\$8,900), Faith Community Church - Naturescaping (\$8,000), Humboldt Neighborhood Association - Albina Tree Initiative (\$8,000). Additional community projects will be awarded mini-grants not exceeding \$500 each for the purchase of native plants for stormwater and natural area restoration projects (\$3,000).
3. The established cost is \$95,000 for the grants and \$3,000 for the native plant mini-grants. Funds are available in the Sewer System Operating Fund, FY 13-14 Budget, Bureau of Environmental Services, Cost Center ESWS000007, GL Accounts 529000 (grants) and 549000 (mini-grants).

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Environmental Services is authorized to execute grant agreements and IGAs for the purpose described in Section 1, in substantially the same forms as Exhibits A and B attached herein, in the amount of \$95,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because grant selection was delayed by budget deliberations. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
