

# ORDINANCE No. 186176

Amend the Regulation of Lobbying Entities code for bureau additions and technical updates (Ordinance; amend Code Chapter 2.12)

The City of Portland ordains:

Section 1. The Council finds:

1. Through City Council Ordinance No. 179843 passed on December 21, 2005 and effective April 1, 2006, Council adopted City Code Chapter 2.12 to establish registration and reporting requirements for lobbying entities and city officials.
2. City Code Section 2.12.070 of this chapter describes requirements of certain bureau directors.
3. In September, 2011, the Council passed Ordinance No. 184880 creating the Office of Equity and Human Rights and in December 2012, the Council passed Ordinance No. 185807 creating the City Budget Office. Additionally, the Bureau of Human Resources, the Bureau of Internal Business Services, the Bureau of Technology Services, and the Bureau of Fire and Police Disability and Retirement are distinct bureaus within the City.
4. City Code Section 2.12.040 contains an erroneous reference to state law.
5. City Code Section 2.12.100 requires publication of submitted reports on the Office of the Auditor's website. As specified in the code, lobbying entities and city officials may amend quarterly reports during amendment periods. The code should be amended to allow publication of the reports following the amendment period because amended reports have caused technical publishing delays.
6. These code amendments will improve the consistency and accuracy of the City's lobbying regulations.

NOW, THEREFORE, The Council directs:

- a. City Code Subsection 2.12.020 C is amended as follows:

C. "City director" means the director or individual in charge of the following or its successors: the Bureau of Transportation, the Office of Management and Finance, the Office of Government Relations, the Office of Neighborhood Involvement, the Bureau of Planning and Sustainability, ~~the Office for Community Technology~~, the Portland Bureau of Emergency Management, the Bureau of Emergency Communications, Portland Fire & Rescue, the Bureau of Police, the Bureau of Parks and Recreation, the Bureau of Environmental Services, the Portland Water Bureau, the Bureau of Development Services, the Portland Housing Bureau, the Bureau of Revenue, the City Budget Office, the

Office of Equity and Human Rights, the Bureau of Fire and Police Disability and Retirement, the Bureau of Human Resources, the Bureau of Internal Business Services, the Bureau of Technology Services, and the Portland Development Commission.

b. City Code Section 2.12.040 D. is amended as follows:

- D. A statement required by this section shall include a copy of any notice provided to a City official under ORS 244.100 (3).

c. City Code Section 2.12.100 is amended as follows:

**2.12.100 Public Nature of Reports, Registrations and Statements.**

All information submitted to the City Auditor in any report, registration or statement required by this Chapter is a public record and will be posted on the Office of the Auditor website within three business days after receipt, except if the information is subject to amendment under this Chapter, the Auditor will post the information within three business days after the amendment period has closed.
