The City of Portland ordains:

Section 1. The Council finds:

- 1. Burlington Water District has requested that the City provide fire prevention, suppression and emergency response services for its property on the terms and conditions described in Exhibit A, attached to this Ordinance.
- 2. The City, through Portland Fire & Rescue, is willing to provide these services to Burlington Water District, as requested and on the terms and conditions set forth in Exhibit A.

NOW, THEREFORE, the Council directs:

a. That the Commissioner in Charge and City Auditor are authorized to execute an Agreement for fire prevention, suppression and emergency response services with Burlington Water District, for the term beginning July 1, 2013 and continuing through June 30, 2014 for the sum of \$109,149.00, paid by Burlington Water District, on the terms and conditions set forth in the Agreement, a copy of which, marked Exhibit A, is attached to this Ordinance.
