ORDINANCE No. 186191

Amend Ordinance to remove Exhibit A relating to the phased implementation of the Northwest Parking Meter District and Area Permit Parking Program (Ordinance; amend Ordinance No. 185805)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No.185805 was passed by City Council on December 12, 2012 creating the Northwest Parking Meter District and Area Permit Parking Program.
- 2. In passing Ordinance No. 185805, Council directed the Portland Bureau of Transportation to phase the implementation of the meter district and the permit program in a manner consistent with Exhibit A.
- 3. Subsequent to the adoption of the Northwest District Parking Management Plan, staffs from the Bureau of Transportation and from the offices of Mayor Hales and Commissioner Novick met with representatives from the Northwest District Neighborhood Association, Nob Hill Business Association and other community stakeholders to identify mutually agreeable modifications to the adopted plan.
- 4. The mutually agreed to modifications include eliminating the phasing schedule as described in Exhibit A of Ordinance No. 185805 and implementing the parking plan beginning in January 2014.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 185805 is amended to delete Exhibit A.
- b. All other terms and provisions of Ordinance No. 185805 remain the same and are not affected by this amendment.
