WHEREAS, on September 12, 2012, City Council accepted a report conveying the implementation plan for captioning media produced by the City of Portland, and

WHEREAS the report directed the development of an administrative rule to establish the City's captioning policy and the development of cost estimates related to the implementation of such a policy, and

WHEREAS, the Office of Equity and Human Rights and the Office of Management and Finance, Bureau of Technology Services, worked together with City staff and Portland community members to develop the administrative rule which is included as Exhibit A, and

WHEREAS, the Office of Management and Finance, Bureau of Technology Services worked with City bureaus to develop cost estimates related to the implementation of the captioning policy and a report of these estimates is included as Exhibit B.

WHEREAS, the Office of Management and Finance will conduct an analysis and will report back to Council after one year of implementation of the City's captioning policy, as is outlined in BTS 3.04,

NOW, THEREFORE, BE IT RESOLVED that Bureau of Technology Services' Administrative Rule ARC-BTS-3.04 – Captioning of Video and Audio Materials be established as shown in Exhibit A.

BE IT FURTHER RESOLVED that this resolution is binding City policy.
